



Privacy Policy

FXGM respects each individual's right to privacy. We value our relationship with you, and we take great pride in maintaining the privacy and therefore the loyalty of each individual client, by providing the required security. The provisions of this notice apply to former as well as current customers.

1. Personal Information

In order to provide you with the very best service, when you apply to become a FXGM customer or open a live account, we will ask you for personal information. This information will assist us in evaluating your financial needs, processing your requests and transactions, keeping you informed about products and services that may be of interest to you, and providing you with a better customer experience.

2. Required Information May Include:

Application Information - full name, address, birth date, identity social security number, occupation, assets, and income.

Transaction Information - Information about your transactions with us and/or our affiliates, records of past communications. These may include: your account balances, trading activity, past inquiries and our responses.

Verification Information – This may be required to verify your identity, and may include passport or drivers license.

Note: Anti-Money Laundering ("AML") regulations and the USA Patriot Act requires financial institutions to collect information and take action, where necessary to verify a customer's identity.

Note: FXGM does not intentionally collect information from persons under thirteen years of age.

3. The Use of Cookies

We use a technology called "cookies", which enables us to provide you a better experience in using our website by sending small text files from our servers to your computer. These cookies do not track your private information.

4. Sharing Information:

a. General Policy

FXGM do not disclose your personal information to third parties, except as described in this Policy. Third party disclosures may include sharing such information with non-affiliated companies that perform support services for your account or facilitate your transactions with FXGM, including those that provide professional, legal, or accounting services to FXGM. Non-affiliate companies that assist FXGM in providing services are required to maintain the confidentiality of such information to the extent they receive it and to use your personal information only in the course of providing such services and only for the purposes dictated by FXGM.

FXGM may also disclose a customer's personal information to a third party in order to fulfill their instructions or pursuant to express consent. It is important to us that you know that FXGM will not sell your personal information.

b. Regulators
